### Presentation: Proposed tax expenditure objectives

Ms. Kristi Schroedl, LBO Deputy Director, introduced the work performed by the Legislative Budget Office (LBO) to document the objectives of the following tax expenditures from the Department of Revenue's Tax Expenditure Budget (TEB).

- Working Family Credit (TEB 1.90)
- Beginning Farmer Management Credit (TEB 1.103)
- Credit for Sale of Agricultural Assets to a Beginning Farmer (TEB 1.104)
- Research and Development Credit (TEB 2.27 / 1.86)
- Employer Transit Pass Credit (TEB 2.28)
- Housing Contribution Credit (TEB 1.97 / 2.32 / 12.09)
- Telecommunications Equipment (TEB 4.21)
- Solar Energy Systems (TEB 4.26)
- Farm Machinery (TEB 4.39)
- Building Materials for Residences of Disabled Veterans (TEB 4.54)

• Construction Materials for Certain City Projects (TEB 4.73)

Mr. Carlos Güereca, LBO Lead Budget Analyst, and LBO Budget Analysts Ms. Xunxuan Weerts, Mr. Joel Enders, and Ms. Laura Cecko introduced each expenditure and summarized the work to prepare the objective. Mr. Güereca also discussed key dates leading up to the commission's first report due to the Legislature December 15, 2022.

The commission discussed whether a vote to approve the contents of the report will be required. Ms. Nora Pollack, Senate Counsel, and Mr. Sean Williams, House Legislative Analyst, discussed the statutes concerning the Tax Expenditure Review Commission. It is left up to the commission to set the policies and procedures for the commission. The statute stipulates the report is submitted to the Legislature by the Commission.
