Bill Description

Subd. 1: Provides definitions of applicable terms for the creation of a special investigation unit in the Bureau of Criminal Apprehension (BCA) for purposes of investigating officer-involved deaths.

Subd. 2: Creates the Use of Force Investigations Unit within the BCA, for purposes of investigating officer-involved deaths. This Office is to be headed by a Special Agent in Charge selected by the Superintendent of the BCA, in consultation with the Commissioner of Public Safety.

Subd. 3: The unit may also investigate conflict of interest cases involving peace officers and other public officials accused of crimes, including but not limited to sexual assault.

Subd. 4: Further, the unit is given the authority to employ peace officers and staff to conduct these investigations and the superintendent must develop and implement policies and procedures to ensure no conflicts of interest with regards to agents assigned to an investigation. BCA resources not directly assigned to the unit may be used to assist the unit in fulfilling the duties noted in this section.

Subd. 5: When a peace officer employed by the BCA is the subject of an officer-involved death investigation, the investigation must be conducted by an investigatory agency selected by the attorney general.

Subd. 6: Outlines the duties of the Superintendent, including the requirement for an annual report to the legislature, the Commissioner, and the Governor, and the necessary components to this report.

Assumptions

The BCA currently investigates the majority of officer-involved shootings (OIS) and in custody death investigations in the State of MN. They are responsible for providing coverage to all 87 counties and must remain on call 24/7 in order to provide timely response. The number of personnel requested to comply with the proposed bill reflects the the staffing needed to maintain a separate specialized unit within the BCA that will be responsible only for OIS and in custody death investigations. These agents and other personnel will be strategically located throughout the state in order to provide timely response to these critical incidents. The tables below show data by case for 2012 to 2020 YTD.

In total, twenty-two positions will need to be filled and would only do the duties outlined in this bill, in a standalone unit.

The first three positions noted are sworn staff and each employee hired for those positions will need the following equipment, supplies, and training per annum, at the noted costs:

The total cost of these items, per sworn staff member, is \$21,500.00 per annum.

The five positions following the sworn staff are non-sworn staff and each employee hired for those positions will need the following equipment, supplies, and training per annum, at the noted costs:

The total cost of these items, per non-sworn staff member, is \$8,800.00 per annum.

The firearms scientist will need the following one-time equipment, supplies, and training:

In addition to the above, the firearms scientist will need \$8,800.00 in annual equipment and supplies.

A lease for agents to be placed in Mankato will also be necessary at a cost of \$15,000.00 per annum.

The total cost of filling each of these positions per annum is \$2,902,948.00

The total cost of providing the fourteen sworn staff's annual equipment, supplies, and training is \$301,000.00 per annum.

The total cost of providing the five non-sworn staff's annual equipment, supplies, and training is \$44,000.00 per annum.

The total cost of one-time lab scientist equipment and initial training is \$93,000.00, to be spent in the fiscal year 2021.

In addition to these one-time costs, the firearms scientist will need \$8,800.00 in equipment and supplies per annum.

All of these items in addition to the lease in Mankato, at a cost of \$15,000.00 per annum, will result in \$3,364,748 in costs in fiscal year 2021 and \$3,271,748.00 in ongoing costs per annum.
