Bill Description

The bill creates an Office of Community-Led Public Safety Coordination within the Department of Public Safety Office of Justice Programs. The Office must promote and monitor alternatives to policing; identify effective forms of community-let intervention to promote public safety; strengthen connections between community members and law enforcement agencies; encourage restorative justice programs; administer grants to promote co-responder models of crisis intervention and promote community healing.

Assumptions

The Legislature will appropriate \$15,000,000 to the Department of Public Safety to support community led-safety. OJP assumes that \$100,000 will fund a community-led public safety coordinator position. OJP assumes that \$7,450,000 will be appropriated to OJP to create a new grant program to promote co-responder teams to de-escalate volatile situations; respond to mental health crisis; promote community-based safety and wellness; and support community-based strategies in response to violence. OJP assumes that \$7,450,000 will be appropriated to OJP to create a new grant program to promote hearing support in the black, indigenous, and people of color communities in Minnesota through community care and healing justice practitioners; establishment and expansion of organizations providing wellness and healing services; funding healers in organizations providing direct service to black, indigenous, and people of color communities; healing circles; establishing and expanding Community Coach Certification. OJP assumes they will be responsible for compiling and reporting on the new grant programs yearly to the legislature.

OJP assumes it will receive up to 2.5% of the grant amount to cover administrative expenses to implement the new grants and reporting requirements and would use this funding to hire two grant managers who would work on this program in addition to the coordinator.

Expenditure and/or Revenue Formula

15,000,000 appropriation -100,000 Coordinator position = 14,900,000 grants x 2.5% admin for OJP = 372,500.

Long-Term Fiscal Considerations

OJP assumes that we receive this appropriation yearly.
