## Approval of minutes

## LBO Update

Christian Larson, Director of the Legislative Budget Office presented an update on the organization, budget, and work of the Legislative Budget Office.

### Proposed Changes to the Fiscal Note Uniform Standards and Procedures

Alyssa Holterman Rosas, Lead Budget Analyst for the Legislative Budget Office, gave an overview of the Fiscal Note Uniform Standards and Procedures and summarized the LBO's proposed changes.

Members gave feedback that the Legislative Budget Office will incorporate into revised proposed changes and provide before the next meeting.

### Future meeting dates and topics

Chair Wiklund asked to check member availability for October 16 for the next meeting. Rep. Elkins suggested adding two items to the list of possible future agenda topics included in previous meeting minutes: fiscal notes where not all factors that impact costs/revenues are considered and using assumptions in a fiscal note that include a third-party contracted amount that would expire before legislation takes effect.
